**REPORT OF MATERNAL DEATHS
PENNSYLVANIA OCCURRENCES, 2016**

The Abortion Control Act requires that deaths occurring in Pennsylvania arising from pregnancy, childbirth, or intentional abortion be reported to the Department of Health (Department). Annually, the Department is to compile a statistical report based upon the data gathered in reports of maternal death. The report is to be available for public inspection and copying.

This is the Department's annual statistical report. The following tables are based on the data submitted in reports required by the Abortion Control Act. Another source of information on maternal deaths is death certificates, also filed with the Department.
